Sir/Madam,

The Government expects all its employees to follow the prescribed code of conduct as contained in the Conduct Rules. Non-observance of these Rules invites penalty which can be imposed on an employee only after proving his misconduct by conducting an inquiry. The Disciplinary Authorities and the Inquiring Authorities while dealing with the disciplinary matters are required to follow the rules prescribed for conduct of inquiry and the principles of natural justice. Delinquent officers, in many cases, go scot free because inquiry against them is vitiated by non-observance of the prescribed procedure. This adversely affects discipline in the Organizations. Training on Disciplinary Proceedings is, therefore, necessary for the officers dealing with administrative and disciplinary matters and also for those who are potential Inquiring Authorities, Presenting Officers and Defence Assistants etc. It is desirable that training on the subject is given to all officers including the officers who have vigilance cases pending against them or against whom such cases are contemplated.

- 2. This Institute is conducting a two-day non-residential Workshop on Disciplinary Proceedings on 16th and 17thMarch, 2020 at **Seminar Hall No. 2, India International Centre, 40, Max Mueller Marg, New Delhi -110003**. The Workshop will cover all important aspects of the subject as per the attached Schedule.
