The remaining 03 members will be nominated by CPCSEA, Animal Welfare Division, Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, O/o Committee for the purpose of Control and Supervision of Experiments on Animals, Krishi Bhawan, New Delhi-110001.

This committee will examine research projects directly or indirectly from ethical point of view. This committee will also examine the facilities and suggest to the Director, AIIMS ways and means to improve the living conditions and up-keep of experimental animals. This committee may also give opinion on ethical issues involving animal experiments in matters referred to it from Government of India, State Government and any other Statutory Body.

This Institutional Animal Ethics Committee will meet every three months. The applications for ethical clearance will be considered within 3 months of submission in the format for ethical clearance prepared by the committee.

The Chairman of Institutional Animal Ethics Committee is authorized to invite/co-opt any other specialist as and when required on case to case basis.


