Subject: - Abolition of affidavits and attestation by Gazetted officers in Public Services and promotion of Self-certification reg.

The under Secretary Ministry of Health & Family Welfare vide letter No. V-16020/48/2015 dated 9th September 2015 enclosing therewith OM No. Z 17015/1/2014 CDN.I dated 27.08.2015 of coordination Section of MoHFW has informed that as per the discussion made in the meeting dated 17.7.2015 under the chairmanship in Secretary, Department of Administrative Reforms & Public Grievances an initiative for abolition of affidavits and attestation by Gazetted Officers in Public Services and Promotion of Self-certification has been taken.

As per the decision taken in the meeting, all affidavits wherever not required under statutes, Rules/Regulations must be replaced by self-certification and self-attestation. Further, the need of attestation by a Gazetted officer may be reviewed. And in all such instances, where the need of attestation by the Gazetted officer is not required as per statutes, ruled/regulation etc., the same may be done away with.

Action may be initiated to revisit and amend the rules, regulations and statutes which provide for such affidavits and attestations.
