Point No. 1(b)

As per AIIMS, Act 1956 Section 15 – **Payment to the Institute.**

The Centre Government may under appropriation made by Parliament by law in this behalf; pay to the Institute in each financial year such sums of money and in such manner as may be considered necessary by that Government for the exercise of its power and discharge of its function under Act.

Point No. 1(c).

As per AIIMS, Act 1956 Section 18(2) – **Accounts and Audit.**

The accounts of the Institute shall be audited by the Controller and Auditor-General of India and any expenditure incurred by him in connection with such audit shall be payable by the Institute of the Comptroller and Auditor-General of India.


