

Minutes of the Meeting of State Grievance Redressal Committee held on Feb 17' 2016 At Delhi Secretariat

The meeting of State Grievance Redressal Committee (formerly known as ART Review Committee Meeting) by in hold on 17.02.2016 at 1500 hrs under the Chairpersonship of Secretary (H&FW), Govt. of NCT of Delhi, clinus Secretary was engaged in urgent assignment, the meeting was chaired by Dr Mrinalini Darswal, Special Secuciory (H&FW), Govt. of NCT of Delhi and Project Director, DSACS at conference hall no. 3, C wing , 2nd Level, Delhi Secretariat.

Special Secretary (Health & FW), Govt. of NCT of Delhi and Project Director, DSACS initiated the meeting with welcoming the participants and officers present in the meeting of the State Grievance Redressal Committee (ART Review Committee) meeting. The chairperson first reviewed grievances of PLHAs and then

the residence pertaining to ART centers hampering provision of care support and treatment services to station to the registered with them. The same were discussed one by one.

allowing actions were suggested.

- 1 ID. DGACS took a serious view on discrimination due to HIV status of any individual in any respective normal example availability of healthcare facilities or employment opportunity/ discrimination in the origing employment. Any discrimination on these grounds or others of due to HIV positive status is completely discouraged by DSACS and appropriate action will be taken as deemed fit against the organization/ individual found doing so.
- 2. The high attrition rate among Doctors and nurses at ART centers due to low remuneration was highlighted by all the committee members. The maximum attrition was seen among doctors. It was observed that DSACS had published central advertisement twice in one year apart from walk-in inferviews in hospitals with ART centers, but unable to fill all vacant positions. Delhi's first FIART center has experienced its three Medical Officer resigning from their position within a short span of six months. DSACS has sent a representation to NACO to enhance the salary of its Medical staff at par with DSHM scale to manage the issue which was not accepted. At present, out of 27 sanctioned positions of SMO/MO at ART centers, only 18 are filled.

APT, LISACS raises the concern over difficulties faced by patients and center staff for less number of declars available in the ART clinic. It was highlighted by all the nodal officers present that repeated complaints has been received from PLHIV Community regarding long waiting hours at ART Centers for medical checkup by Medical Officers. Since a large number of PLHIV patients visiting ART Centers of Delhi come from neighboring states and long waiting hours at the center create great inconvenience to these patients.

PD, DSACS suggested to send the issue to NACO again for their review and approval for providing remaneration equivalent to DSHM scale.

- 3 Sensitization of medical practitioners and healthcare staff was reviewed essential on knowledge of national guidelines on post exposure prophylaxis (PEP). The treatment under PEP must be available at all healthcare facilities. Advisory issued in this regard earlier by Directorate of Health Services will be circulated again to emphasis the relevance of PEP. Also, instructions were that Universal Precaution kit should be available round the clock in all the hospitals and healthcare facilities to avoid any delay in treatment where such kits are required.
- (OI). If was brought into the notice of committee that OI drugs like Gancyclovir/ Valgancyclovir is often required by the ART center is neither supplied by NACO nor provided by the respective institutions. PD, DSACS suggested that since such drugs are essential for treatment of OIs related to fatal heath consequences to HIV patient if not immediately provided; health institutions are instructed to procure the medicine at their own level for HIV patients.
- 6. Other constraint at ART center DDU hospital was again reviewed. Although one room has already to the ART center for counselors, additional space is requested for pharmacy since it is legaled for away from the ART center at the other building of the hospital. PD, DSACS requested Medical Superintendent, DDU hospital to consider the request again.

6. Hodal Officer, ART center, National Institute of TB & RD (NITRD, formerly known as LRS hospital) informed that ARTC was provided approval for refurbishment fund of Rs. 2.5 Lakhs from NACO in June 2014 for its new ART center infrastructure. Earlier, the center was working from a single room. The ARTC took loan from the hospital and new building was made. However, the funds are not yet released by NACO. Since Institute has provided loan for the benefit of HIV programme and thus, PLHIVs. Director of NITRD has also requested PD, DSACS for reimbursement of the amount. PD, DSACS agreed to provide fund to hospital from any savings in CST component budget. DD(Finance), DSACS to take initiate action for release of funds.

The meeting ended with a vote of thanks to the Chair.
