Honorable Supreme Court in 1997 in the matter of Vishaka & Ors Versus State of Rajasthan & Ors had laid down guidelines for protection of women from sexual harassment at workplace. Government of India, pending legislation in the matter, issued detailed instructions on the subject in 1998. The said instructions have now been replaced by the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013. The Act requires all establishments to constitute Internal Complaints Committees. Rule 13 read with Section 19 of the Act makes it mandatory for all employers to carry out orientation programs and seminars for creating awareness about the provisions of the law among their employees in general and members of the Internal Complaints Committees in particular.

This Institute is organizing a two day non-residential Seminar on Prevention of Sexual Harassment of Women at Workplace from 28th August to 29th August, 2017 at Seminar Room No. 1, India International Centre, 40, Max Mueller Marg, New Delhi-110003. Seminar would cover all aspects of the Act and Rules and beyond. It will sensitize all the participants and enable the members of the Complaints Committees to play their role effectively. Schedule of the seminar is given at the end of this letter.
