NOTIFICATION

Subject: Allowing retired EHS beneficiaries and serving ones in specific Situations while out of stations with official intimation to avail treatment anywhere in CGHS empanelled hospitals or otherwise and claiming reimbursement as per CGHS rates. reg.

In continuation of letter of even no. dated 08.05.2015, it is put up that the date of Governing Body meeting (which approved this item) was inadvertently mentioned as 21.04.2015. It may be read as 13.04.2015. This revised notification reads as under:

The undersigned is directed to notify following revised guidelines reg. allowing retired EHS beneficiaries and serving ones in specific Situations while out of stations with official intimation to avail treatment anywhere in CGHS empanelled hospitals or otherwise and claiming reimbursement as per CGHS rates.

- i. EHS beneficiaries who are living in NCR or outside campus can avail emergency medical facility in CGHS Empanelled Hospitals or other private hospitals and reimbursement would be made as per CGHS rates or actuals whichever is lower.
- ii. Retired EHS beneficiaries (those who have subscribed to EHS after paying requisite contribution) who are living outside NCR can avail indoor medical care in CGHS empanelled hospitals or other private hospitals and reimbursement would be made as per CGHS rates or actuals whichever is lower.
- iii. The retired EHS beneficiaries (those who have subscribed to EHS after paying requisite contribution) residing in outside NCR in other cities across the country can avail the emergency medical treatment from any hospital and the reimbursement will be allowed as per CGHS rates of the nearest CGHS city or actuals whichever is lower.
- iv. **In case of elective/ planned medical treatment procedure, the retired EHS beneficiaries (those who have subscribed to EHS after paying requisite contribution) can avail medical treatment in their city on the recommendation of a Government doctor. They will be allowed reimbursement at CGHS rates applicable to the nearest CGHS city or actuals whichever is lower.**
