

As you are aware, in terms of the Notification issued by Department of Financial Services on 31.01.2019, the contribution of Government to the NPS account of Central Government employees has been enhanced from 10% to 14% of Basic Pay and Dearness Allowance.

2. I enclose a copy of the letter dated 07.06.2019 from the Pension Fund Regulatory and Development Authority (PFRDA) addressed to all Principal Accounting Officers of Central Autonomous Bodies (CABs), where they have informed them that the PFRDA has requested Department of Expenditure to clarify whether the above mentioned change is applicable to employees of CABs covered under NPS and until the clarification emerges, the Competent Authority under CAB should obtain a separate and express approval from the Department of Expenditure.

3. This Department has consulted the Department of Financial Services, which is the nodal department in respect of matters pertaining to PFRDA and NPS. DFS have informed, inter-alia that since the notification dated 31.01.2019 is an amendment notification to the principal notification dated 22.12.2003, it is imperative that the changes notified to NPS vide notification dated 31.01.2019 would be applicable to Central Government employees only. DFS have further informed that adoption of any amendment to the scheme for the benefit of employees of CABs is to be decided by the respective CABs at their level in consultation with respective Ministry/ Department who may, if necessary, take up the matter with DoE for concurrence. The adoption of amendment dated 31.01.2019 for employees of CABs entails budgetary consequences, which cannot be addressed by DFS.

4. Accordingly, this Department is at present considering the issue regarding the applicability of the provision of 14% of employers' contribution in case of ABs. In order to take a view in the matter, I request you to provide us the following information:-

- i. Whether the issue of applicability of the aforesaid provision has been considered in the Ministry/ Department under your charge and if so, the details thereof and the action taken may be intimated.
- ii. If a decision has been taken to allow the aforesaid provision in case of any of the ABs, the authority under which it was allowed may be indicated, as this measure will have financial implications

Subject: Necessary instructions for all CABs (Central Autonomous Bodies) concerned with reference to gazette notification P. No. 1/3/2016-PR dated 31/01/2019 issued by Dept of Financial Services (DFS), Ministry of Finance regarding the enhancement of contribution under NPS.

This is with reference to the gazette notification P. No. 1/3/2016-PR dated 31/01/2019 issued by Dept of Financial Services (DFS), Ministry of Finance regarding the enhancement of contribution under NPS.

Under the abovementioned notification, certain changes under NPS have been announced by Central Government including enhanced contribution by the Central Government to its employees covered under NPS from the existing 10% to 14% (to Tier-I account). The changes under said notification are applicable w.e.f. 01.04.2019 for Central Government employees. However, the circular is silent on the its applicability to the employees of the CABs covered under NPS.

In view of the above, PRRDA has requested the Department of Expenditure to clarify whether the above-mentioned changes/modifications under NPS would be applicable to employees of Central Autonomous Bodies (CABs) covered under NPS.

In the interim, PRRDA has been approached by various CABs who have individually obtained their internal approvals for enhancing the employer contribution from 10% to 14% and hence, have sought PRRDA's approval for uploading the same through the existing CRA functionality.

In light of the above and till the time clarification emerges on the matter of applicability of notification dated 31.01.2019 on CABs, it has been decided by the competent authority that the CABs who have obtained such internal approvals, should obtain a separate and express approval/concurrence for the applicability of the said provisions of the notification dated 31.01.19 on their employees from Department of Expenditure (DOE), Ministry of Finance.

Consequent upon receipt of such approval from the DOE, Ministry of Finance, a copy of the referred approval may be forwarded to the CRA, for necessary action at the CRA's end.
