**Sub:- Revision of Recruitment Rules in respect to the faculty posts of Department of Surgical Oncology at the AIIMS, New Delhi.**

It is notified for information of all concerned that the Recruitment Rules for the faculty posts of Department of Surgical Oncology at the AIIMS, New Delhi have been revised as under:

**Essential**

- i) A medical qualification included in Schedule I & II or part II of the third Schedule of the Indian Medical Council Act of 1956 (candidates possessing the qualifications included in Part-II of the third Scheduled should also fulfill the conditions specified in Section 13(3) of the Act).
- ii) M.Ch. in Surgical Oncology (2 years or 3 years or 5 years or 6 years recognized course) or recognized qualification equivalent thereto.
- iii) **Experience**

**For the post of Assistant Professor**

One year teaching and/or research experience in a recognized Institution in the subject of specialty after obtaining the Degree of M.Ch. in Surgical Oncology (2 years or 5 years recognized course) or a qualification recognized equivalent thereto. However, no experience is necessary for the candidates possessing 03 years or 06 years recognized Degree of M.Ch in Surgical Oncology.

**For the post of Associate Professor**

Four years teaching and/or research experience in a recognized Institution in the subject of specialty after obtaining the Degree of M.Ch. in Surgical Oncology (2 years or 5 years recognized course) or a qualification recognized equivalent thereto. **OR** Three years teaching and/or research experience after obtaining the degree of M.Ch. in Surgical Oncology (03 years or 06 years recognized course) or qualification recognized equivalent thereto.

**For the post of Additional Professor Professor**

Eight years teaching and/or research experience in a recognized Institution in the subject of specialty after obtaining the Degree of M.Ch. in Surgical Oncology (2 years or 5 years recognized course) or a qualification recognized equivalent thereto. **OR** Seven years teaching and/or research experience after obtaining the degree of M.Ch. in Surgical Oncology (03 years or 06 years recognized course) or qualification recognized equivalent thereto.

For the post of Professor

Twelve years teaching and/or research experience in a recognized Institution in the subject of specialty after obtaining the Degree of M.Ch. in Surgical Oncology (2 years or 5 years recognized course) or a qualification recognized equivalent thereto. **OR** Eleven years teaching and/or research experience after obtaining the degree of M.Ch. in Surgical Oncology (03 years or 06 years recognized course) or qualification recognized equivalent thereto.
