Sub:- Creation of six (06) posts of Assistant Professors for the Department of Hematology in the pay scale of Rs. 15600-39100 with Academic Grade Pay of Rs 8000/- (Plus NPA) (Pre-revised) at AIIMS, New Delhi - reg.

The undersigned is directed to convey the approval/sanction of the Academic Committee/ Standing Finance Committee/ Governing Body/ Government of India, Ministry of Health & Family Welfare for the creation of six (06) posts of Assistant Professor for the Department of Hematology with the nomenclatures as mentioned below in the pay scale of Rs. 15600-39100 with Academic Grade Pay of Rs 8000/- (Plus NPA) (Pre-revised) plus usual allowances as admissible to Central Government servants of similar status stationed at Delhi/ New Delhi:

- i) 04 (four) posts as Assistant Professor (Clinical Hematology)
- ii) 02 (two) posts as Assistant Professor (Hemato-pathology)

The Recruitment Rules as approved by the Academic Committee/Governing Body in their meetings held on 13.05.2014 & 21.10.2016 respectively for the posts of Assistant Professor (Clinical Hematology) and Assistant Professor of Hemato-pathology at the Institute are as under:

Essential:

- i) A Medical qualification in Schedule I & II of the third Schedule of the Indian Medical Council Act of 1956 (candidates possessing the qualification in Part II of the third Schedule should also fulfill the conditions specified in Section 13((3) of the Act.).
- ii) D.M. in Cl. Hematology/D.M. in Hemato-pathology (2 years or 3 years or 5 years or 6 years recognized course after MBBS) or a qualification recognized equivalent thereto for the posts of Assistant Professor of Clinical Hematology/Assistant Professor of Hemato-pathology respectively.

Experience:

- i) One year teaching and/or research experience in a recognized Institution in the subject of specialty after obtaining the Degree of D.M. in Cl. Hematology/D.M. in Hemato-pathology (2 years or 5 years recognized course after (MBBS) or a qualification recognized equivalent thereto for the posts of Assistant Professor of Clinical Hematology/Assistant Professor of Hemato-pathology respectively. However, no experience is necessary for the candidates possessing 3 years or 6 years recognized degree of D.M. in Cl. Hematology/D.M. in Hemato-pathology.

The above prescribed recruitment rules for the posts of Assistant Professor (Clinical Hematology) and Assistant Professor of Hemato-pathology are, however, under consideration of the competent bodies of the Institute for revision. Until then, the Recruitment Rules for the post of Assistant Professor (Cl. Hematology) as stated above shall be applicable.

The expenditure on these posts will be met out of the sanctioned budget of the Institute.
