Sub: One Day Workshop on "The Rights of Persons with Disabilities Act, 2016" on August 05, 2017 at New Delhi.

Madam / Sir,

Perhaps you may be aware that the Ministry of Law and Justice (Legislative Department) has enacted a new Act "The Rights of Persons with Disabilities Act, 2016" which has come into force with effect from 19th April 2017. Section 34 of the Act provides for reservation not less than 4% of the total number of vacancies in the cadre strength in each group of posts meant to be filled with persons with benchmark disabilities of which, 1%, each shall be reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and 1% for persons with benchmark disabilities under clauses (d) and (e) namely:-

- Blindness and low vision;
- Deaf and hard of hearing;
- Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- Autism, intellectual disability, specific learning disability and mental illness;
- Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities.

2. With a view to providing live rendition to the public authorities on implementation of the provisions of the new Act, the Institute is organising a one day workshop on "The Rights of Persons With Disabilities Act, 2016" on August 05, 2017 at Hotel Piccadilly, Janakpuri District Centre Complex, Janakpuri, New Delhi-110 058, (Tel: 011-41234123) as per the attached Schedule (Annexure-I).


