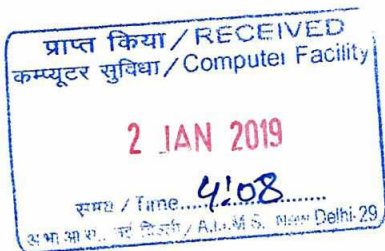

India has ratified the Convention on Elimination of all forms of Discrimination against Women (CEDAW) in 1993. The States parties are expected to submit a National report to the Committee at least every four years, indicating the measures they have adopted to give effect to the provisions of the Convention. India is expected to submit the 6th Periodic Report in 2018. Ministry of Women and Child Development (MWCD) is the Nodal Ministry to compile the National report and submit the same to the Committee.

MWCD has entrusted the task of compiling the National report to National Law University (NLU), Delhi. The compilation of report would need inputs from the Ministries, State Governments & Commissions. The Convention has 30 articles, the articles from 1 to 16 mention areas of concern related to women and the Committee's mandate and the administration of the treaty are defined in the Articles 17 to 30 of the Convention. The details of the Articles can be seen at the <http://www.un.org/womenwatch/daw/cedaw/text/econvention.htm>. You are requested to share your inputs on the articles concerning your Ministry, with an emphasis on schemes pertaining to these areas and the implementation of these schemes. The areas of concern related to women as per the said articles are enlisted below for your ease of reference:
