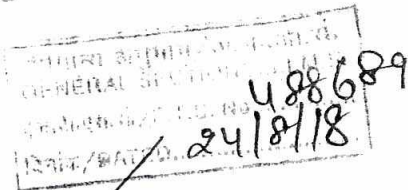
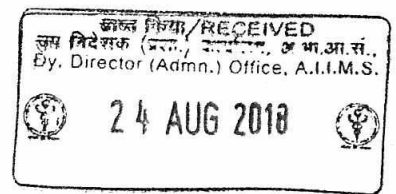

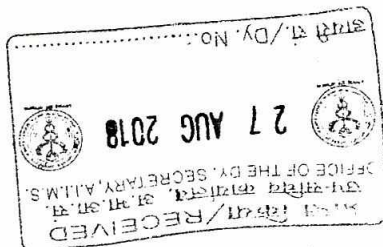

OFFICE MEMORANDUM

Subject: Meeting to review the adoption and expansion of Government e-Marketplace (GeM).

The undersigned is directed to refer to the review meeting on adoption and expansion of GeM taken by Commerce Secretary on 06.08.2018 wherein it was advised that as per Rule-149 of GFR, the procurement of goods & services by Ministries or Departments is mandatory for goods or services available on GeM. Any purchase outside the GeM platform may be made only with the recommendations of Standing Committee of Government e-Marketplace (SCoGeM) and approval of the Secretary.

Commerce Secretary mentioned in the above meeting that substantial improvement in procurement on GeM is targeted for a period of 45 days i.e. during August 15th to 2nd October, 2018. GeM has identified Ayushman Bharat for this mission mode activity for 45 days and procurement worth Rs. 237 crore is targeted for this programme during the said period.

NHM is implementing Ayushman Bharat mission. Central Government Hospitals, AIIMS, INI's are the other major procuring departments. The above departments are requested that preparation be made for a special drive to procure substantially higher value of items through GeM during the above mentioned period.


