ORDER

WHEREAS disciplinary proceedings under Rule 14 of the Central Civil Services (Classification Control and Appeal) Rules, 1965 was initiated against Sh. Anil Kumar M.G., Nursing Officer vide Office Memorandum No.F.45-478/2010-Estt.(TC) dated 20th May, 2021 on the following **Article of Charges :-**

“That the said Sh. Anil Kumar M.G., while working as Nursing Officer at JPNATC has been absenting himself from duty w.e.f. 25.01.2021 willfully and unauthorisedly without prior sanction of leave by the Competent Authority in spite of issuance of various Memoranda dated 11.02.2021, 12.03.2021, 26.03.2021 & 08.04.2021 asking him to submit the explanation and report back to duty. However, Sh. Anil Kumar M.G. neither replied to the above said memoranda nor joined back the duty so far.

By his aforesaid act, Sh. Anil Kumar M.G. has exhibited lack to devotion to duty and has acted in a manner unbecoming of an Institute employee thereby contravening Rule 3 (1) (ii) & (iii) of the CCS (Conduct) Rules, 1964, as applicable to the employees of the Institute.”

AND WHEREAS a statement of imputation of misconduct was sent to Sh. Anil Kumar M.G., Nursing Officer with aforesaid memorandum dated 20/05/2021 with direction to submit a written statement of his defence on the above charges. However, he did not submit any reply.

In the meanwhile, Sh. Anil Kumar M.G., Nursing Officer vide letter dated 05.07.2021 (received on 07.07.2021) has tendered his resignation from the services of the Institute due to some personal reasons. Accordingly, Sh. Anil Kumar M.G., Nursing Officer was directed to remit the outstanding amount of Rs.4,06,891/- vide this Office Memorandum dated 07.10.2021. However, Sh. Anil Kumar M.G. neither deposited the outstanding amount nor replied to the aforesaid Office Memorandum.

Accordingly, Sh. Bhoop Singh, Administrative Officer was appointed as Inquiry Officer by the Disciplinary Authority to inquire into the charges framed against Sh. Anil Kumar M.G., Nursing Officer vide Order No.F.45-478/2019-Estt.(TC) dated 9th July, 2021. The Inquiry Officer, after holding the inquiry had submitted his report vide letter dated 2nd December, 2021 and concluded that the charge framed against Sh. Anil Kumar M.G., Nursing Officer stands Proved.

AND WHEREAS a copy of the Inquiry Report had been forwarded under provision of Rule 15 of CCS (CCA) Rules 1965 to Sh. Anil Kumar M.G., Nursing Officer to enable him to submit his representation/submission, if any, in writing within 15 days to the Disciplinary Authority on the Inquiry Report vide Memorandum No.F.45-478/2010-Estt.(TC) dated 11th January, 2022. However, no reply has been received from Sh. Anil Kumar M.G., Nursing Officer against the Inquiry Report.

NOW, THEREFORE, after careful consideration of the Inquiry Report, all facts and circumstances of the case, the President, AIIMS being Disciplinary Authority, in exercise of the powers conferred under Rule 15 of the CCS (CCA) Rules 1965 read with Regulation 33 of AIIMS Regulation 2019, now for good and sufficient reasons has decided to impose the penalty of **"Dismissal from service which shall ordinarily be a disqualification for future employment under the Government"** on Sh. Anil Kumar M.G., Nursing Officer.

Accordingly, the penalty of **"Dismissal from service which shall ordinarily be a disqualification for future employment under the Government"** is imposed upon Sh. Anil Kumar M.G., Nursing Officer with immediate effect.

A copy of this Order be added to the confidential roll of Sh. Anil Kumar M.G., Nursing Officer.
