**NOTIFICATION**

**Subject: Declaration of Assets and Liabilities and filing of returns by public servants under Section 44 of the Lokpal and Lokayukta Act, 2013 and rules framed- reg.**

The undersigned is directed to refer this office circulars of even number dated 15.04.2015, 18.05.2015, 05.04.2016, 22.04.2016, 27.07.2016 and 09.08.2016 on the above cited subject, it is intimated that as per DoP& T OM No. 407/16/2016-AVD-IV (LP) dated 01<sup>st</sup> December, 2016, regarding the furnishing of information relating to the assets and liabilities by public servants under section 44 of the Lokpal & Lokayukta Act, 2013 (the Act).


2. In this regard, it is stated that with the passing of the Lokpal and Lokayukta (Amendment) Act, 2016 (copy enclosed), the Public Servants (Furnishing of information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Returns) Rules, 2014 and all the amendments made there to have become redundant.

3. The Lokpal and Lokayukta (Amendment) Act 2016, as referred to above, substitutes the provision of section 44 of the Principal Act by the following new provisions-

"44 on and from the date of commencement of this Act, every public servant shall make declarations of his assets and liabilities and such form and manner as may be prescribed".

4. Thus, under the Public Servants (Furnishing of information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Returns) rules 2014, there is no requirement for filing of declarations of assets and liabilities by public servants now. The Government is in process of finalising a fresh set of rules. The said rules will be notified in due course to prescribe the form, manner and timelines for filing of declaration of assets and liabilities by the public servants under the revised provision of the said Act. All public servants will henceforth be required to file the declarations as may be prescribed by the fresh set of rules.

The contents of the said OM may please be brought to the notice of all the concerned employees of AIIMS, New Delhi.
