WHEREAS, Shri Ashish Kumar, MRT was promoted to the post of Jr. Medical Record Officer in the Level-5 in the pay matrix (Pre revised PB-1 5200-202000+2800 Grade Pay from the date he assumes the charge of the post of Jr. Medical Record Officer at NCI, Jhajjar within seven days from the date of issue of this office order failing which it will be presumed that he has denied his promotion as per vice O. M. No. F 2-24/2018-Estt. (RCT) dated 14.02.2019.

AND WHEREAS, Shri Ashish Kumar, MRT had submitted a representation dated 20.02.2019 to the Director, AIIMS that Shri Kamal Singh, MRT is senior to him and therefore he may be promoted to the post of Jr. MRO against that vacant post. He was promoted before his Senior (Shri Kamal Singh, MRT) which is against the rules because seniority could not be bypass and first vacant post must be offered to senior first.

AND WHEREAS, his representation has been examined in detail and the Competent Authority considering that Shri Kamal Singh, MRT may be promoted to the post of Jr. Medical Record Officer against first vacant post, which is available due to refusal of promotion by Shri Rajan Kumar, MRT, as he is the senior most MRT in the list. Accordingly, the office order of even no. dated 14.02.2019 regarding promotion of Shri Ashish Kumar, MRT to the post of Jr. Medical Record Officer in the Pay Matrix Level -5 (Pre revised PB-1 Rs. 5200-20200+2800 GP) is hereby treated as cancelled/withdrawn.
