Promotion to the post of Nursing Superintendent at NCI, Jhajjar AIIMS, New Delhi.

Consequent upon the recommendations of the Departmental Promotion Committee held on 30.08.2018 and its acceptance by the Competent Authority, Mrs. Pushpa Lata-II, Deputy Nursing Superintendents is promoted to the post of Nursing Superintendent in Level 11 in the Pay Matrix (prerevised Pay Band-3 of Rs.15600-39100 with Grade Pay of Rs.6600/-) from the date she assumes the charge of the post of Nursing Superintendent at NCI, Jhajjar within 7 days from the date of issue of this office order failing which it will be presumed that she has denied her promotion.

She will be entitled to such other allowances as are admissible from time to time to the Institute Employees of her status stationed at Delhi/New Delhi/in the Rural Centre presently located at Ballabhgarh (Haryana), Jhajjar (Haryana) and NDDTC, Ghaziabad.

She will be on probation for a period of two years. During the period of probation, she will be required to put in satisfactory service failing which her service will be liable to be reverted at any time without any notice or reason being assigned for the same.

She is advised to exercise her option for fixation of her pay under FR-22(I) either from the date of her promotion or from the date of drawl of her next increment in the present post within one month from the date of issue of this Office Order, provided she has not been granted Pay Level 11 in the Pay Matrix (pre-revised Pay Band-3 of Rs.15600-39100 with Grade Pay of Rs.6600/-) under ACP/MACP Scheme.

Other terms and conditions of her service will be the same as are applicable to other employees of the Institute.
