They will be entitled to such other allowances as are admissible from time to time to the Institute Employees of their status stationed at Delhi/New Delhi/in the Rural Centre presently located at Ballabhgarh (Haryana), Jhajjar (Haryana) and NDDTC, Ghaziabad.

They will be on probation for a period of two years. During the period of probation, they will be required to put in satisfactory service failing which their service will be liable to be reverted at any time without any notice or reason being assigned for the same.

They are advised to exercise their option for fixation of their pay under FR-22(I) either from the date of their promotion or from the date of drawal of their next increment in the present post within one month from the date of issue of this Office Order, provided they have not been granted Pay Band-2 of Rs.9300-34800 with Grade Pay of Rs.4800/- under ACP/MACP Scheme.
