

b.	Which agency has been awarded the contract for the watch & ward services for year 2014-15?	Institute entered into two separate contracts with responsive security agencies for watch & ward services of different areas under Unit-'A' & Unit-'B'. Under which, M/s. Security and Intelligence Services (India) Ltd. & M/s. Swift Securitas Pvt. Ltd. was awarded contract for different areas under Unit-'A' & Unit-'B' respectively with effect from 07.07.2012 to 06.07.2014 and extended upto 15.04.2015.

Swift Securitas Pvt. Ltd., M/s. Bombay Intelligence Security (India) Ltd., M/s. Scientific Security Management Services (Pvt. Ltd. &amp; M/s. G4S Secure Solution (India) Pvt. Ltd.</u> were opened under Unit-'B' except <u>*M/s. Security and Intelligence Services (India) Ltd.</u> being L-1 bidder for Unit-'A' as per terms 8.10.6 laid down in tender provisions provided as under:</p> <p><i>"Financial Bid (for technically qualified bidders only) for Unit -A (Envelope 2) will be opened first. Total evaluation shall be done and lowest quoting firm shall be identified as L-1 bidder for Unit -A. Thereafter, if the same bidder has also quoted in Unit -B, his financial quote for Unit -B would be returned unopened to him. Financial bids of remaining eligible and technically qualified bidders for Unit -B would be opened next and the evaluation shall be done and lowest bidder so identified shall be termed as L-1 bidder for unit -B".</i></p>
