1. Presently two Security Agencies namely M/s. Security and Intelligence Services (India) Ltd. and M/s. Bombay Intelligence Security (India) Ltd. have been providing Security Services for different areas at AIIMS, New Delhi. In this regard it is to say that till date we have not received the above said amount. Therefore you are once again requested to deposit an amount of Rs. **Rs.312/- (Rupees three hundred twelve only) upto 10.08.2017 so that requisite information may send to you at earliest.**
