NOTICE

Sub.: Debarring of M/s Rohanika Electronics & Medical Systems for a period of One (01) year for participating in tender/ purchase of Suction Machine & Patient Warming System at AIIMS - New Delhi. - reg.

**Ref. No.-1, Tender No. - 17/H/M&E/2018-19, purchase of Suction Machine.
2, Tender No. - 65/H/M&E/2018-19, purchase of Patient Warming System.**

This is with reference to your reply (Letter No.- QTN/D/CCD/18-19/4008/4114/L2, dated: 04/10/2019) to the show cause notice issued by the Institute on 04/10/2019. In this regard, you are hereby informed that your reply has been considered and found unsatisfactory on account of the following reasons.

"The tender floated/ published by AIIMS at CPPP clearly required the bidder to disclose if there has any blacklisting/ deregistering/ barring irrespective of the product or time period. However, you failed to declare your debaring with the PGIMER-Chandigarh. Consequently, action was initiated against you for violating the code of integrity and not because debaring was for a particular product or time period or otherwise".

The same has already been discussed with you during the personal hearing meeting held on 10/08/2019. It is unfortunate that a firm which has served the Institute so well in the past should have held important information from the Institute. Your reply to the show cause notice has not discerned the fine line between information in Govt. tenders provided on one's integrity.

In view of the above, undersigned is directed to convey the approval of the Competent Authority to debar your firm i.e. *M/s Rohanika Electronics & Medical Systems (C-49, Okhla Phase - I, New Delhi - 110020) for a period of One (01) year for participating in tender/ purchase of Suction Machine & Patient Warming System from AIIMS w.e.f. 16/10/2019 for a period of 1 (One) year* due to violation of tender agreement by submitting false undertaking and violated Non-disclosure agreement while participating in the tender published by Store Section - Main Hospital, AIIMS for purchase of Suction Machine (17/H/M&E/2018-19) & Patient Warming System (65/H/M&E/2018-19). Further, it has been decided to forfeit the Earnest Money Deposit (EMD) amounting to Rs.- 40,000.00 (Forty Thousand) deposited against tender No.- 65/H/M&E/2018-19 by your firm (M/s Rohanika Electronics & Medical Systems).
