MEMORANDUM

Subject: Submission of Annual Immovable Property Return for the year 2016 (as on 1.1.2017) by all Group 'A' & 'B' Officers of the Institute – regarding.

Please refer to Vigilance Cell Memorandum of even number dated 2.1.2017 on the above subject. In terms of Rule 18 of CCS (Conduct) Rules, 1964, Annual Immovable Property Return (AIPR) for the year 2016 (as on 1.1.2017) is required to be furnished by all Group 'A' & 'B' Officer of the Institute by 31.1.2017. It has been observed that number of Group A & B Officers of the Institute have not yet submitted their Annual Immovable Property Return for the year 2016 (as on 1.1.2017).

Filing of AIPR within the stipulated time/period is mandatory and non-submission of the AIPR within the stipulated time period/date leads to the denial of vigilance clearance in accordance with DoPT instructions issued vide O.M. No.11012/11/2077-Estt.A dated 27.9.2011. Non-submission of AIPR leads to administrative difficulties while processing their case(s) for vigilance clearance.

In view of above, all the Chief of Centres/Head of the Departments/Sections/Units are again requested to kindly direct the Group "A" and "B" Officers working under them, who have not yet submitted their AIPR, to file their Annual Immovable Property Return (AIPR) for the year 2016 (as on 1.1.2017) with the Vigilance Cell, AIIMS without any further delay. The proforma for filing Annual Immovable Property Return for the year 2016 is annexed herewith.
