
Sir,

Gupta, Advocate.	The matter is under examination. Therefore, no information is provided keeping in view of para 8(1)(h) of the RTI Act, 2005. Part (b) pertains to LegalCell of the Institute, concerned information may be directly obtained from CPIO, Legal Cell, AIIMS, New Delhi.
10.	There was screening test held for deputing JAO training. The Recruitment Cell contrary to Recruitment Rules, proposed some employees to the training against the Recruitment Rules or on whims and fancies of the Recruitment Cell, AIIMSD. Is any vigilance case is pending looking into these complaints. If yes, provide me the status of the inquiry and the name of the officers involved.	complaint against the selection process to fill up the posts of Jr. Accounts Officers was received in the Vigilance Cell and after examining the same, a communication was sent to administration on 05.09.2016 for course of action in the matter.
