Quotations should be sealed in an envelope and Reference No. & Name of the Item (i.e. L.T.E No. clearly written on top of the envelope. The submitted quotations will be opened on 20.2.2017 the Item ' (Monday) at 3.00 P.M. in the Office of the undersigned, Room No. 4057, 4th Floor, Teaching Block,
- 2. The firm must be registered and having TIN No./ Registration No. (Please mention TIN/Registration No. on the bids) or else the quotation will be REJECTED.
- 3. The bidder is required to submit the bid in two parts viz:
  - Technical Bid in one envelope containing of the following information:
    - i. Technical descriptions of the quoted model (s)
    - List of all consumables/accessories required for running the equipment
    - iii. Terms & conditions including Warranty/CAMC/Taxes etc.
    - iv. Original catalogues of the quoted model (s)
    - Earnest Money Deposit (EMD)
