If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any

bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Special terms and conditions-Version:2 effective from 08-03-2024 for category Fire Proximity Suit (V3)

- This category is for a complete set of firefighting suit consisting of Coat and Trouser (BIS marked as per IS 16890 specification indicated in category parameter), Fireman Helmet Type B, Fireman Gloves (BIS marked as per IS 16874 specification indicated in category parameter), Fireman Boots and Antiflash Hood. This is a bid-only category and buyers are required to indicate the required size of various components while creating the bid.
 - 2. Sellers are required to inform that the BIS license for the BIS mark items in the set is valid and shall indicate the correct BIS license no. while creating the catalogue.
 - 3. Educational Instructions to be indicated for the benefit of the user
 - 1. Items are to be used in close proximity to the fire but never lower than a distance of 1 meter from the fire
 - 2. Fire proximity suit is never to be used for fire entry purposes
 - 3. The fire suit needs to be inspected after each use to determine if it is suitable for deployment as exposure to fire accidents can potentially damage the fire-fighting suit, rendering it unsuitable for deployment until repaired.

- 4. Wash Care
- 1. It is recommended to wash and maintain the fire suit regularly. This will ensure that the fire proximity suits are clean and suitable for deployment after being exposed to previous fire-fighting activity. Manufacturers may indicate suitable instructions regarding wash care.
- 5. Instructions regarding Storage and Repair
- 1. Manufacturers are required to indicate instructions regarding Storage and repair. This may cover the following details as well as any other information considered appropriate by the manufacturer.
- 2. Improper storage could modify the clothing features and protective levels therefore users may keep clothing dry and clean in a suitable place at ambient temperature and humidity. It may be ensured that the suit is not exposed to heat or cold surfaces at the time of storage.
- 3. For repairing the clothing it is recommended to use only materials like the ones used for the manufacturing of the clothing, No other materials must be used and repairs must be carried out only by an experienced person.
- 4. The clothing is manufactured with high-quality components and therefore durable and maintains protective features, However, protective features can be subject to degradation in the long run as a result of the condition of usage.

7.Since BIS Mark is compulsory for the coat and trouser as well as fireman gloves for this category it shall be ensured by the vendor assessing agency that OEM is holding valid BIS licence for the same at time of vendor assessment .For entities eligible for VA exemption on account of turnover also valid BIS licence is required to be eligible for exemption.
