**crystallization kits**

1. The crystallization kits should contain the crystallization conditions of known protein structure from protein data bank
2. The kits should be compatible with mosquito (TTP Labtech) installed in department of biophysics.
3. Polyethylene glycol - salt screen solution with 96 conditions should be provided.
4. Iodine derivatives phasing kit should be provided for solving structures using MIR methods
5. Mercury derivatives phasing kit should be provided for solving structures using MIR methods.
6. Salt with varying pH kits for screening with 96 conditions should be provided
7. DNA-protein complexes screening kit minimum 96 conditions should be provided
8. Initial crystal screening kit for soluble proteins minimum 96 conditions should be provided.
9. RNA and other nucleic acid crystallization screening kit 96 conditions should be provided.
10. A total of sixteen numbers of kits should be provided
10. All the kits should have warranty period of 2 years.
11. Vendors can check the mosquito if required.

Vendors should provide the product certification by one of this agency: CE/IVD certified or European Union EMC & Safety Compliance Declaration or FCC - North American EMI Verification or UL - North American Product Safety Certification or Demko or VDE - European Union Product Safety Certification.
