Warranty/ Guarantee	2 years

**Technical specifications**

1. Should be provided in adult/child (20 nos. ) and infant sizes (20 nos.)
2. Should be light weight, easy to use
3. Material should be PVC and should not contain latex
4. Should have a one way hydrophobic filter that filters out contaminants in the air being transferred between the care provider and the patient.
5. Should have provision for oxygen inlet that facilitates delivery of oxygen
6. Should be provided with a strap
7. Should allow use with a bag device
8. Operating temperature should be -10 to 40° C and operating temperatures should be -40 to 50° C.
9. Conductor surface area should be atleast 85 cm square
10. Should be easy to clean and reusable
11. Should be provided with a case
12. Should be provide with accessories such as valve 06 nos. for Infant mask and 06 nos. for adult/child mask
13. Safety certified according CE 93/42, FDA 510k or equivalent (Certificate to be submitted)

**TERMS & CONDITIONS:**

1. The quotations should be addressed to 'Professor & Head, Department of Pediatrics, Room No. 3058, AIIMS, New Delhi-29' and sent by post/ courier by **22 July 2016 up to 2.00 P.M.** Quotations should be sealed in an envelope and the reference no. and item name clearly written on top of the envelop. (i.e. S.R.E No. **08/Paed/CPR Pocket masks/PICU/2016-17/Plan** quotation for the item **CPR Pocket masks**)
2. The firm must be registered and having TIN no./ registration no. (**Please mentioned TIN/ registration no. on the bids**) or else the quotation will be treated as cancelled.
3. The bidder is required to submit **bid in two parts** viz (a) Technical Bid in one cover (b) Commercial bid in one cover. Both bids should be packed in a separate sealed envelope.
4. The offered make/brand should be mentioned on the bid. **Sample or relevant literature/original catalogue should be submitted along with the technical bid failing with item would not be considered.**





5. Quotation should be typed/ written in ink. No overwriting or erased entries should be there in the quotation. The rates **should be valid for at least six months**.
6. VAT/Sales tax or any other kind of tax(s) must be separately mentioned against each item. In case no sales tax is chargeable, prices must be quoted as NET PRICE.
7. **Warranty/Guarantee:** The item must be covered under 2 years comprehensive warranty from the date of supply.
8. **An affidavit should be enclosed with the technical bid state 'that the firm has deposit the VAT TAX/ SALE TAX of last period, and there is no outstanding of taxes is pending against the firm'.**
9. The firm has to give a certificate that the firm has not been blacklisted in the past by any Institution, Government/Private.
10. The firm has to give an affidavit on a non-judicial stamp paper that there is no vigilance/CBI case pending against the firm/supplier.
11. The firm has to give an affidavit on a non-judicial stamp paper that the firm is not supplying the same item at lower rates quoted in the tender to any government organization or any other institution during past 1 year, as per FALL CLAUSE adhered by DGS & D and other government agencies.
12. The firm must be able to supply the item at the mentioned place/location within stipulated time for supply after issuing the Supply Order.
13. The payment will be made electronically viz RTGS/NEFT after delivery and satisfactory installation of the item.
14. The quantity can be increased or decreased in the extent of 25%.
15. The Professor & Head of the Department reserves the right to cancel/reject full or any part of the rate enquiry which generally do not fulfill the conditions stipulated in the rate enquiry.
