Flash Autoclave Table Top Vacuum

- 1) Machine must be European CE mark, ISO 13485 compliance, ASME (American Society of Mechanical Engineers) certified for complying ASME boiler and pressure vessel code
- 2) Equipment shall be microprocessor based automatic system from add water to sterilization & dry cycle
- 3) Chamber capacity shall be 22-25 Liters (Chamber size: 250 x 450 mm)
- 4) Overall dimensions of the machine should be (W x H x D) mm (530-540 x 440-450 x 650-660) mm
- 5) Voltage: 230V AC, 50/60Hz
- 6) Sterilization temperature should be 121° or 134° Celsius
- 7) Machine should perform pre & post vacuum functions

- 17) Must have flash function
- 18) Feature of selectable dry time 0 – 60 min
- 19) It will have additional features like temperature control, overheat protection, safety valve, electronic circuit with fuse protection, error indicator, low water indicator, sterilization complete indicator, emergency exhaust button, automatic preheating programme
