Sealed quotations are invited by post / per bearer on following Terms & Conditions.

Terms & conditions:

1. The quotations should reach this office (**Room No. 2083, 2nd floor, Office of the Head of the Deptt.**) on or before: **07th September 2018 up to 04:00 p.m.** duly sealed & marked: **RATE ENQUIRY: RE-02/R.B./M&E(PLAN)/RE/2018-19**. All quotations should be type written. Quotations written in pencil will not be entertained.

2. TENDER SHOULD INVARIABLY BE SUBMITTED IN TWO BID SYSTEM CONTAINING TWO PARTS AS DETAILED BELOW:

PART-I: - TECHNO COMMERCIAL BID IN ONE SEALED COVER

PART-II: - PRICE BID/ FINANCIAL BID IN ONE SEALED OVER.

BOTH THE SEALED ENVELOPES SHOULD THEN BE PUT IN OUTER COVER INDICATING THEREON:

PLEASE NOTE THAT QUOTED PRICE SHOULD NOT BE INDICATED IN THE TECHNO-COMMERCIAL BID. **TENDERS SUBMITTED WITHOUT FOLLOWING TWO – BID SYSTEM PROCEDURE AS MENTIONED ABOVE WOULD BE SUMMARILY REJECTED.**

3. The accredited agent or sole representative quoting on behalf on their manufacturer / principal must attach valid authority letter from their manufacturer / principal.

4. The tender rates should be kept open / valid for a period of six months from the date the tenders are opened.

5. If the delivery is not effected by due date, **the Head of the Department of Reproductive Biology, AIIMS, New Delhi** will have the right to impose penalty as under:

a) First extension for month or part thereof _____ @2%

b) Second extension for an additional month or the part thereof _____ @3%

c) In case of non-supply _____ @7.5%

Further, in case of non-supply of material within the due date i.e. within the date of delivery, the Head, Department of Reproductive Biology, AIIMS, New Delhi will also have the right to impose penalty like forfeiture of performance security and removal of the name from the list of

the contractor for minimum 02 years and resort to risk purchase in full or part thereof at his /her direction. His/ her decision shall be final and binding.

Or

- d) In case of default institute will have the right to procure the ordered item from open market / another party at their own risk and expenses under risk purchase clause, under this clause, the extra paid amount will be recovered from the 1st lowest firm, who is liable to supply the goods.*
- 6. Handwritten quotations shall be accepted at the bidder's risk. In case of any discrepancy in the figures, the rate mentioned in words only will be considered.*
- 7. Each tender should be accompanied with an EMD/BID Security amounting to Rs. 5000/- by way of FDR/Demand draft drawn in favour of "THE DIRECTOR AIIMS, NEW DELHI" failing which the tender shall not be considered for acceptance and will be outrightly rejected. Cash / cheque is not acceptable at all. SUCCESSFUL BIDDER WILL HAVE TO SUBMIT 10% performance SECURITY (OF TOTAL CONTRACT AMOUNT) BY WAY OF FDR/ DEMAND DRAFT DRAWN IN FAVOUR OF "THE DIRECTOR AIIMS, NEW DELHI" valid up to warranty period plus 3 months more from the date of letter of acceptance, failing which administrative action like debarring of approved firm for minimum of 38 months for participating in future tenders and forfeiture of EMD/BID security at AIIMS shall be taken. THE EMD/ BID SECURITY AND PERFORMANCE SECURITY DEPOSITED AGAINST OTHER TENDERS CANNOT BE ADJUSTED OR CONSIDERED FOR THIS LIMITED TENDER.*
- 8. The Head, Department of Reproductive Biology, AIIMS, New Delhi shall be the final authority to reject in full or any part of the supply which is not conforming to the specification and other terms and conditions.*
- 9. No payment shall be made for rejected material. The supplier should remove rejected items within one week of the date of rejection at their own cost & replace immediately. In case these are not removed, these will be disposed off in a manner deemed fit by the authorities at the risk and responsibility of the suppliers without any further notice.*
- 10. The firm should submit an undertaking on firm's letterhead that it has not been blacklisted in the past by any government /private institution and there is no Vigilance/CBI case pending against the firm / supplier.*
- 11. The quantity shown in the tender can be increased or decreased to any extent depending upon the actual requirement.*
- 12. The firm must quote rates including freight, insurance, cartage, labor charge & other taxes etc. on FOB, AIIMS, New Delhi basis.*
- 13. If required, the firm should be able to give demonstration of the item within one week of requisition. In case bidder fails to give demonstration strictly in accordance with tender specifications, administrative action shall be taken like forfeiture of PBG & debarring of firm for minimum 02 years at AIIMS. The counter offer shall be given to L-2 bidder to match the L-1 price and to supply the item as per tender terms.*

14. *The court of Delhi will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other than the Delhi court shall have jurisdiction in the matter.*
15. *Tender by Tele-fax /telegram /fax/e-mail will not be accepted.*
- 16. Fall Clause:**
*“The price charged for the Stores/equipments, under the reference by the supplier shall in no event exceed the lowest price at which the supplier has supplied the Store/equipment of same identical description to any other person /organization/ Institution during the current financial year. If at any time, during the said period, the supplier reduced the said prices of such Stores/equipments or sell such Store to any other person /organization /institution at price lower than the chargeable, he shall forthwith notify such reduction or sale to the **Head, Department of Reproductive Biology, AIIMS, New Delhi - 110029** and the price payable for the Stores supplied after the date of coming into force of such reduction or sale shall stand correspondingly reduced”.*
17. *Firm will submit fall clause undertaking, as above, on their firm’s letterhead in the technical bid.*
18. *The vendor should enclose the copy of GST Registration of the firm.*
19. *Generally, the date of delivery for supply or items will be 30 to 45 days from the date of issue of the supply order but in exigency the same can be reduced up to 2 weeks depending upon the situation /requirement.*

Specification for Heating water bath circulator – 2 Nos.

1. Water Bath capacity of 10-15 L with Digital LED display.
2. It should have temperature range from ambient to 100°C
3. Temperature uniformity of $\pm 0.01^\circ\text{C}$ & temperature sensitivity of $\pm 0.1^\circ\text{C}$
4. Heater should have 1500-2000W (fast heating)
5. It should have inbuilt timer facility
6. It should have digital temperature controller with 3 pre-sets for frequently used temperatures
7. It should have powerful water circulating pump
8. It should have calibration capability
9. Internal & External tank made up of stainless steel
10. Immersed components are corrosion resistant
11. It should have over-temperature/low liquid alarm
12. It should have hinged gable cover

General Terms & Conditions

1. Power: 220-240 V
2. US-FDA/Europe CE certification
3. The Vendor should have a good service and application support back up along with instruments to provide an effective application related troubleshooting and support
4. The vendor should provide comprehensive onsite training on the operation of the instrument
5. **Warranty: Comprehensive warranty for 3 Years including all parts & labor.**
6. Users list
7. **UPTIME & DOWNTIME PENALTY CLAUSE :** The firm should provide uptime guarantee of 95% during warranty & CAMC period. During the warranty period and CAMC period, desired uptime of 95% of 365/366 (Leap year) days (24 hrs.), if downtime is more than 5%, the warranty period/CAMC period will be extended by double the downtime period. In addition a penalty equal to the amount of 0.25% of the total cost of the equipment per day will be liveable for the excess downtime period.
