4. Blood Parameters: Haemoglobin with Hematocrit, HbA1c, Blood Glucose, Lipid Profile: Triglyceride, HDL, LDL, Total Cholesterol
5. Urine Parameters: Glucose, Protein, Ketones, RBC, Leucocytes, Albumin creatine ratio, Urobilinogen, pH, nitrates, specific gravity.
6. Vision: Colour Vision, Visual acuity
7. Auditory Functions : Pure tone audiometry
8. Fraility Test : Memory Function Test, Handgrip strength
9. Scanning of radiograph.
10. Device should have battery backup of atleast 15 minutes.
