The quotation should reach this office on or before **01-03-2019**. Up to **12.00** Noon duly sealed marked **S.R.E. No. 14/NDDTC/Drugs/18-19/ST**. All quotation should be typed written. Quotation written in pencil or ink will not be entertained. Quotations with eraser /overwriting will be deleted from the list of participants. The rates should be valid at least for six months or till finalization of the centralized rate contract for these items. Percentage of GST must be indicated along with the rates.

The approved vendor has to supply the Nicotine gums 2 mg. Approved firm has to supply the items after issue of the confirmed supply order.

The vendor must quote the above items of original make only, in case found defective, the same will be rejected and will be replaced without any extra cost.

Firm should submit the authorization certificate from the principle manufacturer. Firm also submit undertaking that rates quoted by them not higher than those, which are charged from other Govt./Semi Govt in India.

Firm provide the order copy of any reputed/Govt. organization for above mentioned items.


Firm provide the GMP/NABL certificates for the same.

The EMD/Bid Security of **Rs. 5,000/-** shall be deposited through Demand Draft in favour of the **Account Officer NDDTC, AIIMS**. The **original Earnest Money with quotation** must be submitted in the office of **Store Officer NDDTC, Store Section at NDDTC, AIIMS Ghaziabad**.

If required, the department have reserve the right to call the firm to provide sample of their offered product for quality verification before/after opening the quotation. If offered item does not compatible/suited with the requirement the bid may be rejected. Also if the company fails to provide the sample within 2-4 days of requisition, the bid will be rejected.
