

1. Should have Fluorescence excitation 405nm (blue light)
2. Should have Fluorescence signal 635nm (red)
3. Should have Leica FL400, fluorescence kit for 5-ALA-PDI/neuro for Leica M720 OH5
4. Should have Observation filter module for Leica M720
5. Should have automated in-/out of excitation- and observation filters
6. Should have Leica fluorescence control unit for mode control by microscope handgrip with indication of the mode (LED)
7. Should have automated control signal for mode controlled video camera. Should be prepared for the needs of Leica OH5 400W light source for IntenseBlue
8. The company should provide onsite training and certification for all the faculty of neurosurgery to use this modality
