All quotations should be typewritten or in ink. All over writing and erased entries will be deleted from the quotations. The rates should be valid at least for one year.

The tenders are required to deposit security of Rs. 5,000/-through a Demand Draft/Pay order drawn in favour of the AIIMS, CNC, Accounts, New Delhi-29, before submission of the quotations, failing which the same will not be considered. The quoted items having quality mark such as I.S.I/C.E. mark/ISO9002 Standardization should be mentioned if any.




