All quotations should be typewritten or in ink. All over writing and erased entries will be deleted from the quotations. The rates should be valid at least for one year.

The tenders are required to deposit security of Rs. 5,000/-through a Demand Draft/Pay order drawn in favour of the AIIMS, CNC, Accounts, New Delhi-29, before submission of the quotations, failing which the same will not be considered. The tenders already having such security deposited are not required to deposit the same again but they will indicate the number and date of the cash receipt by which the firm had deposited the security purchase shall be made at the cost and risk of the contractors, and or liquidated damages will be recovered from them.

RADIATION PROTECTION COAT APRONS

- a) It should be for front protection only
- b) Apron should be light in weight.
- c) Lead equivalence should be 0.5 mm (pb).
- d) All models should ideally have anti skid pads resulting in comfort of wearing over shoulders.
- e) Radiation protection apparel should incorporate high quality protection sheet of even thickness.
- f) Stains of blood, contrast, bile etc. should be easily washable.
- g) Apron fabric Color choice and embroidery of name should be possible. It will be responsibility of vendor to embroider the name/logo on the aprons as and when desired by the department within 2 months of purchase .
- h) The product should be US FDA enlisted.
- i) The manufacturer must offer minimum 1 year guarantee on core material against any manufacturing defect..
- j) Product should be quoted in 2 different sizes separately.
