- 1. These should be sturdy double walled units with outer chamber made of Stainless Steel Sheet.
- 2. Inner chamber made up of Stainless Steel Sheet.
- 3. Beaded heating elements should be present at bottom and two sides.
- 4. Inner chamber should be provided with ribs for adjusting perforated shelves to convenient height.
- 5. Synthetic door gasket should be made up of neoprene rubber and should fit to all units.
