Technical Specifications

Patient Warmer specifications:-

- 1. Should have preferably 4 set temperatures for warming.
- Should preferably have hose end nozzle clip & Sheet Clip for easy use of blankets and reduce drag of hosepipe.
- Should have low maintenance requirements.
- 4. Should have forced air warming technology and have short warm up time.
- Should have accuracy of +/- 1°C, supported by authenticated paper.

- The firm must be registered and having TIN no./ registration no. (Please mentioned TIN/ registration no.) on the bids) or else the quotation will be REJECTED.
