

TECHNICAL SPECIFICATION FOR THROMBELASTOGRAPH ANALYZER

1. The equipment must be based on Hartert Principle.
2. Assesses different phases of clot formation and clot breakdown detected through electromagnetic sensor.
3. Two (2) independent measuring channels per analyser, eight (8) channels per computer.
4. Each channel to provide complete information from a single test (instead of multiple testing) from clot formation till clot lysis under one roof & not in isolation.
5. Should be able to work on various types samples like:
 - a. Native Whole Blood sample
 - b. Citrated whole Blood sample
 - c. Heparinised Whole Blood sample/ citrated Heparinase whole blood.
6. Data transfer from analyser to PC.
7. Each channel should be individually temperature controlled and can be adjustable as per patient's core body temperature for accuracy of results.
8. Should provide results for R time, K time, Alpha/Angle, MA/Maximum Amplitude, Lysis Percentage, C.I.
9. User/operator must be able to handle (print/view) all previous data when equipment in use.
10. Equipment should have small size and weight < 6 Kg.
11. Equipment should be CE or US FDA certified.
12. Equipment should perform Electronical, Mechanical and Biological Calibration.
13. All reagents or consumables should have longer storage self-life as well as usable self-life and will be supported by product insert/literature.
14. Company must quote for all tests / reagents / consumables required to perform the following tests:
 - a. Kaolin Test
 - b. Heparinase Test
 - c. Functional Fibrinogen Test
 - d. Rapid TEG Test
 - e. Platelet Mapping Test






