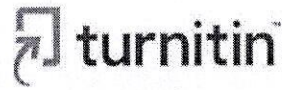

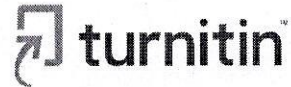



Technical Specifications for Plagiarism Check Software for Medical Literature	
S.No.	(A) Essential Features of software:
1.	It should be a web-based interface hosted by a secure data centre
2.	It should be accessible from any place through login/password control
3.	It should be capable of searching all medical literature available on the day of search on the internet in the form of scholarly journals, periodicals, books, reports, and e-books with valid DOI even if it is password controlled.
4.	It should be capable of loading, checking, and assessing large file sizes in different formats such as Microsoft Word, HTML, XML, rich text format, PDF, Open Office, etc.
5.	It should have a facility for plagiarism checks for commonly used file formats such as Word, PDF, etc.
6.	It should have a word-to-word matching ability with the exclusion of common words, phrases, and medical terms. It should be able to identify and report copy-paste with source identification.
7.	It should provide an overlap/similarity percentage with a detailed report of the sources that are similar to the article being assessed. This report should be downloadable.
8.	There should not be any word limit for plagiarism check in one go.
9.	The pricing for different numbers of manuscripts/ pages to be assessed per annum should be provided.
10.	The company should have technical assistance available in Delhi NCR. It should have support available 24X7 for all technical issues.
11.	The company should have developed or provided similar software for other institutes of repute like AIIMS and should have a good track record.
12.	The software should include all types of available medical literature publisher's databases listed in the Cross-Ref websites in their similarity check database coverage of medical literature databases.
(B) Features of the report generated	
1.	Originally report generation with date & time, name, location, word count, and author of the document that has been checked
2.	A summary of the relative amount of plagiarized portion of the checked document, the original document, and the referenced part if any should be shown in different colors/ highlighted portions in the source document.
3.	The report should show the original and copy source in side-by-side columns.
4.	There should not be any change in the format after the report is generated.
5.	The software should be demonstrated to the concerned authority, Library committee, and A proper training schedule is required for library staff as per the requirement.


Subject: Justification for procurement of Institutional Subscription of plagiarism Detection Software/Tool for AIIMS Library as proprietary item


With reference to the subject cited above that, The Honorable Director Sir, directed "to procure earlier i-Thenticate Anti-Plagiarism Tool/Software, Institutional Subscription in the library as early as possible and also recommended to procure it, as a proprietary item"


In this regard, the library has already received letter Ref. No. L. No. FAIMS/49/2022 dated. 11.01.2023 about that AIIMS library does not have any Plagiarism Detection Software. Previously, i-Thenticate software was available in the library which was widely used by the Faculty members and scientists for their research and academic work the various department faculty members requested that i-Thenticate software requirement in the library.


The concerned librarians tested the "DrillBit" software by uploading the manuscripts and compared the results of the output plagiarism report of "Drillbit" with the earlier software i-Thenticate after the analysis of the reports but the results of DrillBit software were not found satisfactory due to its limited coverage of medical literature/database. The software should include all types of available medical literature publisher's databases listed in the Cross-Ref websites in their similarity check database coverage. The Turnitin i-Thenticate is used worldwide by leading publishers, academics, and researchers at higher education institutions


Dr. B. B. Dikshit Library has used the i-Thenticate plagiarism detection software tool as the proprietary item of Turnitin India Education Private Ltd from August 2015 to 4th August 2022.
