The quotation should reach this office on or before 26.11.2015 up to 12.30 PM duly sealed marked "**Tender No. F-22/(AMC LPG Equip./2015-16/ Café** due opening on the same day i.e. 26.11.2015 at 03.00 PM. All quotation should be type written. Handwritten Quotations will not be entertained. All overwriting and erased entries will be deleted from the quotation.

Each Tender Should be accompanied with an EMD/BID security amount to The Rs.5,000/- by way of FDR/DEMAND DRAFT drawn in favour of AIIMS CAFETERIA New Delhi failing which the tender shall not be considered for acceptance and will be out rightly rejected. Cash/ Cheque is not acceptable at all. The EMD/BID security deposit against other tenders cannot be adjusted or considered for this vender/Rate Inquiry. No interest is payable on EMD/ BID security.

. The approved tendered shall liable to sign the contract/agreement, if required within 15 days (Fifteen days) from the date of issue of the letter of acceptance.

The Director AIIMS reserves the right to cancel/reject any quotation or fresh tender without assigning any reason.

The firm may visit site to the Main Cafeteria to evaluate the work after getting permission from the Head of the Cafeteria Department.

TERMS & CONDITIONS

- (i) That this contract shall be effective for a period of two years from the date of its execution which can also be extended further on mutual agreement.
- (ii) The Firm should be authorized for this work by Indian Oil Corporation/Hindustan Petroleum/Bharat Petroleum
- (iii) The perfect functioning of Cooking Gas Pipe line and Kitchen equipment round the clock with regard to technical servicing etc, shall be arranged by the contractor without fail through their skilled and trained Engineers/Mechanic.
- (iv) The contractor shall be responsible to carry out the proper maintenance of the Cooking Gas Pipe line and kitchen equipments **mentioned in (SCHEDULE 'B')** installed in the Main Cafeteria and its extension counters and ensure that these will be in working condition, the services will include the following:-
 - A Thorough cleaning of dust and other carbon particles which are arch enemies of proper working of instruments and equipments.
 - B Proper adjustment on the basis of standard specification thus ensuring satisfactory performance.
- (v) The contractor shall visit regularly (fortnightly) to the Main Cafeteria for preventive & emergency calls shall also be attended as and when ever required.
- (vi) A list of spare parts mentioned in enclosed Schedule 'B' of specific standard company (ISI) e.g. United, Saka, Intel etc. which would be required for replacement during the tenure of the AMC contract. The contractor should mentioned/ submit their cost/ price of these spares.
- (vii) The renderers must quote rates including freight, Insurance, Cartage, Labour Charges etc on FOB , AIIMS New Delhi basis .Statutory liability i.e. VAT etc should be clearly clarified.
- (viii) In case SOS/Emergency calls, the contractor must report within 4 hours and complete repairs within 24 hours
- (ix) The work of repair with maintenance of these equipments should be done well in time . If the contractor dose not compliance with the conditions AIIMS Cafeteria will be free to get repair work done from local market to meet the urgent requirement and difference in amount will be recovered from the approved contractor. A Penalty of Rs 200/- per day per item will also be imposed if the items is not repaired within 3 working days (which can be reduced to 2 days in case of exigency) after information about the same is given to the vendor (verbal/ written)
- (x) The vendor should enclose the copy of VAT registration.
- (xi) In case of default Institute have the right to procure/ obtain services from open market/ another party at their own risk and expenses under risk purchase clause.
- (xii) The replacing of spare parts has to be hand over the worn out parts to the General Manager, Café or his nominee in the Main Cafeteria.
- (xiii) The firm has not been blacklisting in the past by any government/ Private institution and there is no Vigilance/CBI case pending against the firm.
- (xiv) Payment will be made by Cheque on half yearly basis.
- (xv) The court of Delhi will have the jurisdiction to try matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other court shall have jurisdiction in the matter.
