The quotations duly signed and marked as “SRE No.06/18-19/project/CRHSP/Ballabgarh/” (PRICE BID & TECHNICAL BID separately) should reach the office of the Professor In-charge, CRHSP, Ballabgarh on or before **13.11.2018 at 5.00 P.M.** All quotations should be type written. All over writing and erased entries will not be considered and treated as deleted entries from the quotations. The rates should be valid at least for one year. **A clause by clause compliance statement should be submitted, failing which the quotation will not be considered.**


The tenders are required to enclose with the quotation an **Earnest Money of Rs.10,000/- (Rupees Ten Thousand only) through a demand draft/pay order drawn in favor of the “Director, AIIMS”, failing which the quotation will not be considered.** In case of failure to comply with the supply order in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the supply order should be specified.

The offers submitted as quality A, B, C, & D etc., will be summarily rejected, any alteration/over writing in the specification / rates shall not be considered at all.

The opening of quotations/tenders (technical bid only) will be intimated to the bidders separately. The quantity shown in the Short Rate Enquiry can be increased or decreased to any extent depending upon the actual requirement.

Terms and Conditions:-

1. The firm should be able to give demonstration of the item, if required, within one week of requisition. The firm must supply the item with 30 days after confirmation of order.
2. Unit should be offered with 05 years warranty.
3. Bidder to quote for 05 years CMC after the warranty period i.e. 6-10 year.
4. Machine should be ISO/CE/USFDA marked.
5. Rates should be quoted with all taxes i.e. GST.
6. A clause by clause compliance statement should be submitted.
7. Price Reasonable Certificate.
8. An undertaking on the official letterhead of the company that the firm has not been black listed.
9. An undertaking on the official letter head of the company that no Vigilance case is pending against the firm.


- Should be able to operate different kinds of Hand pieces of high speed Drills
- The system should be user friendly and the parameters should be able to adjust from the control panel
- Should be able to adjust the irrigation levels and bur speed with the touch screen control.
- Should have inbuilt pumps each for Irrigation (5 cc / Min to 100 cc / Min)
- Should have large Touch screen monitor
- The various parameters should be able to adjust either from touch screen panel or from the multifunction foot switch
- Should have multifunction ergonomically designed foot control with light emission for easy identification
- Surgeon should be able to control from the foot control itself the Speed / Mode
- Should have option for remote control Irrigation to operate from sterile area by the surgeon himself.
- Stapes drill should have the speed of 12000 RPM
- Mastoid drill should have the speed up to 60000 RPM
- Should have the provision to mount the console on various sizes of IV poles
