Operating temperature is preset to 36.9°C or can be factory reset to meet individual requirement. Panel is easily removable for decontamination. Unit comes with a polycarbonate stand. Redundant temperature controller prevents overheating. A 100-120 volt AC transformer to step down power to 12 volt DC for use with the test tube heater. Alternate power supply.

The make of the article offered should invariably be quoted. Quotation should be typed written in ink. All overwriting and erased entries will be deleted from the quotation. The rates should be valid for at least SIX MONTHS.

VAT/Sales tax or any other kind of tax(s) must be separately mentioned against each item. In case no sales tax is chargeable, prices must be quoted as NET. The firm must supply the item within 30 days after confirmation of order. The payment will be made electronically viz RTGS/NEFT against delivery and satisfactory installation of the item.
