Payment Terms

- a) Payment shall be made against submission of "Installation and Acceptance Certificate" of good s to be issued by the End User subject to recoveries, if any, either on account of non-rectificatio n of defects/deficiencies not attended by the Supplier or otherwise. "Installation and Acceptanc e Certificate" need to be issued by the concerned End User after installation, commissioning, te sting and successful trail run (if applicable).
- b) The payment for turnkey/ Civil/Electrical/Air-Conditioning Works shall also be made on submissi on of "Installation and Acceptance Certificate" by the End User.
- c) The consignee will enter into CAMC with the supplier at the rates as stipulated in the contract.
