Specification of pipettes:

1. Should be capable of aspirating & dispensing liquid of variable volumes.
2. Should have accuracy of $\pm 0.6\%$ & precision of $\pm 0.15\%$.
3. Should be autoclavable to remove simple decontamination.
4. The Pipettes should be piston-stroke pipette that operate according to the air-cushion Principle.
5. The pipettes should have a control button with 2 stop (measuring stroke & blow-out).
6. It should have a setting ring to set the volume.
7. Should have an ejection button to eject the tip.
8. It should have an adjustment opening with overlapping calibration seal for inserting the wrench during adjustment.
9. It should have an ejection sleeve to extract liquids from long vessels.

The quotation should reach this office on or before **19-10-16** up to **12.00 Noon** duly sealed marked **Rate enquiry No. 03/ NDDTC/lab. Item/16-17/ST**. All quotation should be type written. Quotation written in pencil or ink will not be entertained. Quotations with eraser /overwriting will be deleted from the list of participants. The rates should be valid at least for three months or till finalization of the centralized rate contract for these items. Percentage of VAT must be indicated along with the rates.

The approved vendor has to supply the items within 30-45 days but in case exigency the delivery period can be reduced from the date of issue of the supply order. Approved firm has to supply the items after issue of the confirmed supply order.

The vendor must quote the above items of original make only, in case found defective, the same will be rejected and will be replaced without any extra cost.

Firm should submit the authorization certificate from the principle manufacturer. Firm also submit undertaking that rates quoted by them not higher than those, which are charged from other Govt./Semi Govt in India.

If required, the department have reserve the right to call the firm to provide sample of their offered product for quality verification before/after opening the quotation. If offered item does not compatible/suited with the requirement the bid may be rejected. Also if the company fails to provide the sample within 2-4 days of requisition, the bid will be rejected.
