All quotation should be type written. Quotation written in pencil or ink will not be entertained. Quotations with eraser /overwriting will be deleted from the list of participants. The rates should be valid at least for three months or till finalization of the centralized rate contract for these items. Percentage of GST must be indicated along with the rates.

The vendor must quote the above items of original make only, in case found defective, the same will be rejected and will be replaced without any extra cost.


Firm should submit the authorization certificate from the principle manufacturer. Firm also submit undertaking that rates quoted by them not higher than those, which are charged from other Govt./Semi Govt in India.

Supply order copy of above mentioned item should be submitted by the firm (if available).

### Specification for Urine Cassette Test

1. The cassette test should be rapid, one step, competitive binding immunoassay test for screening of following drugs separately in human urine.

<u>Test</u>	<u>Cut-off</u>
i. Morphine	300ng/ml
ii. Buprenorphine	10ng/ml
iii. Tramadol	100ng/ml
iv. Benzodiazepines	300ng/ml
v. Barbiturates	<del>200ng/ml</del> 300ng/ml
vi. Amphetamine	1000ng/ml
vii. Cocaine	300ng/ml
viii. Cannabis (THC)	50ng/ml

2. The test should be meant for in vitro diagnostic medical use and can be stored at room temperature.
3. The expiry date of the kits should not be less than one year.
4. The kits should be FDA/CE certified.

#### Additionally the vendor should provide

1. Authorization letter of the manufacturer.
2. List of users in India for each drug cassette.
3. Lowest rate certificate.
